#### Introduction

Welcome to our privacy policy. We respect your privacy and are committed to protecting your personal data. This policy explains how Solumed (Pty) Ltd. ("we", "us", or "our") collects, uses, shares, and protects your personal data when you use our website, platform, and services.

#### **Audience**

This policy applies to:

## What Type of Personal Data Do We Collect?

We may collect the following personal data:

- Account Information: Full name, email address, job title, employment type, and contact information.

- Third-Party Integration Data: As permitted by you and subject to third-party privacy settings.
- Live Chat and Inquiries: Name, email address, and message content.
- Newsletter Subscription: Email address.
- Event Participation: Data from contests, surveys, events, and job applications.
- Usage Data: Log files, device information, browser type, IP address, location.
- Financial Data: Bank account details and purchase history.

# Why Do We Use Your Personal Data?

We process your personal data to:

- Provide and manage services you request;
- Improve and personalize your experience;
- Ensure platform security and detect/prevent fraud;
- Comply with legal obligations;
- Conduct marketing, with your consent;
- Manage business operations, auditing, and troubleshooting.

# Legal Basis for Processing

We will only process your personal data where:

- You have given consent;
- It is necessary to perform a contract with you;
- We are legally obliged to do so;
- We have a legitimate interest, provided it does not override your rights.

## **Sharing Your Personal Data**

We may share your data with:

- Affiliates and subsidiaries;
- Service providers (e.g., hosting, customer support, analytics);
- Professional advisors (e.g., legal, financial);
- Authorities for fraud prevention or legal compliance;
- Parties in business transfers, subject to confidentiality.

### **International Data Transfers**

Your personal data may be transferred outside your country of residence. We ensure safeguards such as:

- Standard Contractual Clauses;
- Adequacy decisions;
- Binding Corporate Rules.
- By using our services, you consent to this transfer.

## Marketing

You can opt out of marketing communications at any time using the unsubscribe link in our emails. You will still receive service-related messages.

## **Data Security**

We implement appropriate technical and organizational measures to protect your data. However, internet transmission is not 100% secure.

#### **Data Retention**

We retain personal data only as long as necessary for:

- Providing services;
- Complying with legal and contractual obligations;
- Conducting audits;
- Resolving disputes.

After this, data is securely deleted or anonymized.

## Children's Data

We may process children's personal data strictly on behalf of and under the instructions of our customers, such as healthcare providers and medical institutions. The responsibility for determining whether children's data is collected lawfully and the necessary consent or authorisations have been obtained rests with our customers.
